Directions to Franchise Tax Board's Central Office

The Franchise Tax Board is located at **9646 Butterfield Way, Sacramento, CA 95827**. You can drive, bike or get **easy access via Regional Transit** or Elk Grove Transit. Bike racks are available for your use.

REGIONAL TRANSIT (RT) – Take the Gold Line (Folsom/Sunrise) Light Rail to Butterfield Station. We are in the brick buildings directly behind the light rail platform. Although parking is free, carpooling or RT is recommended.

DRIVING FROM RANCHO CORDOVA/FOLSOM/EL DORADO HILLS – take Hwy 50 West toward Sacramento. Exit at Bradshaw Road (after Mather Field Road). Turn right onto Bradshaw Road and continue over the light rail tracks. Turn left on Folsom Boulevard. Continue on Folsom Boulevard for one block. Turn left at Butterfield Way. You will enter a roundabout; exit the circle at the second right. Turn right at the first gate into the visitor parking lot on your right.

DRIVING FROM DOWNTOWN - take Hwy 50 East toward Placerville/South Lake Tahoe. Exit at Bradshaw Road (after Watt Avenue). Turn left onto Bradshaw and continue over the freeway. Turn left on Folsom Boulevard. Continue on Folsom Boulevard for one block. Turn left at Butterfield Way. You will enter a roundabout; exit the circle at the second right. Turn right at the first gate into the visitor parking lot on your right.

PARKING/CHECK IN - Make the first right turn into the first row of parking spaces (Row F4 on the lamp post). These spaces are marked for visitor parking; park in any open visitor space. If there are no available visitor parking spots, additional parking is available in the parking lot across the street. Note – please do not park in the RT parking lot. Walk toward the flagpoles and continue down the walkway (in between two brick buildings) to the North Lobby. **The SAODN meeting is in the North Lobby, Town Center, Room – Golden State A** (look for a poster in Lobby). You do not have to check-in with Security as the meeting is in a room that is open to the public.
